Dear Ms. Clapper:

Thank you for the form letter. Hopefully State Farm will be sending out thousands of these as the cancellations mount up.

First of all I am no longer a customer of yours. I was for over 40 years and probably spent over \$120,000 with you in today's dollars. It's gone because of your support for the National Council of La Raza.

I'm reading YOUR comment about the NCLA stating, "despite mischaracterizations by others, it's neither a radical nor racist hate group. How do I know this? Because like hundred's of America's largest companies from GE and Microsoft to Fox News (including many of our competitors like Allstate and Geico) we have had a relationship with NCLR for years."

Really?

Jose Angel Gutierrez, former president of La Raza Unida: "Our devil has pale skin and blue eyes [...]. We have an aging white America. They are dying. We have got to eliminate the gringo, and what I mean by that is if the worst comes to the worst, we have got to kill him. [...]. We remain a hunted people. Now you think you have a destiny to fulfill in the land that historically has been ours for forty thousand years. And we're a new Mestizo nation."

Former President UCLA Chapter of MEChA student arm of La Raza. and Current LA Mayor Antonio Villiaragosa , "For those of the race, everything, for those outside the race, nothing."

The Mecha Declaration of Independence defines other objectives of La Raza:

Mecha Student Arm of La Raza Declaration of Independence for AZTLAN:
"In the spirit of a new people that is conscious not only of its proud historical heritage, but also of the brutal 'gringo' invasion of our territories, we, the Chicano inhabitants and civilizers of the northern land of Aztlan from whence came our forefathers, reclaiming the land of their birth and consecrating the determination of our people of the sun, declare that the call of our blood is our power, our responsibility, and our inevitable destiny...With our heart in our hands and our hands in the soil, we declare the independence of our mestizo nation. We are a bronze people with a bronze culture. Before the world, before all of North America, before all our brothers in the bronze continent, we are a nation, we are a union of free pueblos, we are Aztlan." El Plan de Aztlan, published by MEChA, a radical Latino group that advocates for the la Reconquista of California, New

Mexico, Nevada and parts of Colorado and Texas, i.e. "Aztlán."

Let me respond to what State Farm's years of a relationship with La Raza (the race), a racist, hate group, has done to this country. They advocate for one race/one group only. They advocate for law breakers. They advocate for a pathway to citizenship for those who have entered this country illegally. They protect members of their race that are felons from local law enforcement by openly discouraging the enforcement of immigration laws by local authorities. They advocate for driver's licenses for illegal aliens. If you are here illegally, why are you driving? Want the names of people killed by illegal alien drivers? Would you like to speak to a family in San Diego whose daughter was killed by an illegal alien driving a concrete truck drunk that rear-ended her car? There are more people killed by illegal aliens each year than have died in Iraq. La Raza advocate for guest workers. These aren't guests. These are foreign nationals that broke into this country. What about those waiting in line and obeying the laws? The Dream Act wants citizens to pay for the education of illegal aliens by offering them instate tuition. We don't give that to citizens from other states!! After 911 and 3000 dead, where is national security in this debate? Yes, I want local authorities to have the ability to check the identity of any one including you and I Participants in the destruction of the NYC Towers were also here illegally!!

NCLR is engaged in many immigration issues including the REAL ID Act, Comprehensive Immigration Reform, state and local police enforcement of immigration laws, the DREAM Act, AgJOBS, driver's license access for immigrants, and post 9-11 civil liberties.

The "Agricultural Jobs, Opportunity, Benefits, and Security Act of 2007" (AgJOBS), H.R. 371/S. 340, is a bill that would help hundreds of thousands of farm workers across the U.S. legalize their immigration status.

The "DREAM Act" is federal legislation that would facilitate state efforts to offer instate tuition to undocumented students and provide certain students with a path to U.S. citizenship.

There have been several attempts to involve state and local police in the enforcement of federal civil immigration laws. While the safety and security of our communities and our country are of the utmost importance, new policies that would allow local police departments to enforce federal civil immigration law will hinder terrorist and other criminal investigations, and have a serious negative impact on Latino communities.

How about their state policies? This taken from the NCLR web site:

NCLR strongly supports measures to ensure that people of limited English proficiency receive quality and accessible health care, and that communication and/or language barriers, which compromise health care, are eliminated.

NCLR supports legislation that will ensure immigrants' ability to obtain a driver's license.

In recent years there has been much legislation and other activity in the states which impose harsh restrictions specifically on immigrants' access to state-issued driver's licenses and identification documents. More recently, the REAL ID Act passed which imposes federal standards on state-issued driver's licenses. NCLR

believes that a state-issued DL should be reliable proof of an individual's identity and proof of authorization to drive a motor vehicle; it should not be tied to an individual's immigration status.

Is it now clear to State Farm that La Raza is a political action group with a separatist agenda? You should be standing squarely in opposition specifically to driver's licenses for illegal aliens! How many illegal aliens have been involved in accidents with State Farm policy holders?

Let 's speak to State Farm's money spent with them" to develop a healthier business environment, build safer communities and promote an educational system that better meets the needs of our children. And their efforts" to reduce youth violence, welfare, home and auto safety, community development and home ownership".

Illegal aliens drive down the wages of American workers. For every dollar in taxes they pay, it costs us three dollars. California, in 2005, spent \$10 Billion dollars supporting illegal immigration. We have 40,000 gang members, including the violent MS 13, just in LA alone. Most of them are illegal aliens. 95% of the felony arrest warrants in LA are for illegal aliens. Our school system went from near the top to near the bottom. Do you want the state school statistics showing the percentage of English learners in our schools? In particular learners by the language Spanish? You will see pictures of these "fine students" flying the Mexican flag above the upside down US Flag on the web site. Our communities have been over run while you give La Raza money to advocate for the illegals. 86 hospitals/ER's have closed in CA because of State Farm's support of La Raza. I ask you again, why would I or any citizen want to pay for the education, medication, incarceration, and welfare services to those here illegally? All the while destroying the wages of American workers? Why would I give money to ANY company that is supporting the destruction of my community? This is in direct opposition to your statement "we remain committed to our good neighbor heritage as we continue to support and work with community groups to develop safer, stronger and better educated communities." Please visit Los Angeles and take a tour of East LA. See your money at work. We'll stop at a Home Depot and see the illegals standing outside urinating on the sidewalks. Want to speak to hispanics who oppose La Raza? I can arrange that too! I'm a vet. The American Legion has come against any amnesty/guest worker plan. There's 2.7 million members of the Legion. It is the largest service organization in the US. It's our intention to let American Legion members know what State Farm does to to give their jobs to illegals instead of vets who have been shot up in Iraq. 50,000 of the enclosed flyers have already gone out. Your agents are being contacted. You can continue to expect your position to come up on National and local talk radio. The President of the AFL/CIO, John Sweeney, has come out in opposition to any amnesty or guest worker plan. Those millions of union members are going to be contacted and told of the State Farm's money being used to trash them and their communities.

To your statement "While State Farm is not involved in the current public policy debate about immigration, we will continue to operate consistent with the laws of this land.", we say BALONEY! You are in over your head and complicit with this lawlessness. Your money promotes lawlessness. Did you not give \$500,000 to the Southwest Voter Registration Project in 1998? This group supports illegal aliens. You are not a good neighbor!

Even bigger are the people who respond thanking us for making them aware of your position. For every one cancellation you aren't getting another 5 even wanting to do business with you. They go out the back door while your advertising falls on deaf ears.

If you ask what's in this for me? State Farm is NOT going to destroy my family, community and country. Is there a choice? For State Farm there is. See the enclosed solicitation by Farmer's supporting the March of Dimes. Nice huh? Place your sponsorship dollars with a truly charitable organization and get out of this conflict. Do you agree with Jose Angel Gutierrez and Mayor Viilliaragosa and their racist comments, or are you going to support American citizens and the laws of the land? Simple choice.

P.S. We have posted this response letter and your original letter on the web site.

"In the first place we should insist that if the immigrant who comes here in good faith becomes an American and assimilates himself to us, he shall be treated on an exact equality with everyone else, for it is an outrage to discriminate against any such man because of creed, or birthplace, or origin. But this is predicated upon the man's becoming in very fact an American, and nothing but an American...There can be no divided allegiance here ! Any man who says he is an American, but something else also, isn't an American at all. We have room for but one flag, the American flag, and this excludes the red flag, which symbolizes all wars against liberty and civilization, just as much as it excludes any foreign flagWe have room for but one language here, and that is the English language....and we have room for but one sole loyalty and that is a loyalty to the American people."
